AGREEMENT

This Agreement made this day of , 2024, (the "Agreement") is entered into by and between Diakon Child, Family and Community Ministries, headquartered at One South Home Avenue, Topton, PA 19562 ("DCFCM") and the Loyalsock Township School District ("LTSD").

Whereas LTSD desires to provide mental health assessment and treatment services to students in its schools; and

Whereas DCFCM is qualified to provide such services.

NOW THEREFORE, in consideration of the mutual covenants contained herein and intending to be legally bound, the parties agree as follows:

- 1. <u>Mental Health Counseling Services</u>. DCFCM shall provide mental health therapy services to students who are not able to pay through Pennsylvania Medicaid.
- <u>PAYMENT.</u> LTSD will pay DCFCM for Mental Health Counseling Services at a rate of Eighty Dollars (\$80.00) per therapy session. Total payment not to exceed ten thousand dollars (\$10,000).
- 3. <u>Compliance</u>. DCFCM employees performing services under this Agreement shall adhere to the applicable Code of Ethics for their discipline, the standards of DCFCM with all applicable federal and state laws and regulations related to this Agreement and the services to be provided hereunder.
- 4. <u>Term and Termination</u>. The Agreement may be renewed for additional one-year terms by mutual agreement of the parties. Any changes to the fees charged for Mental Health Counseling Services shall be agreed upon at the time of renewal. This Agreement may be terminated at any time by either party upon thirty (30) days' written notice.
- 5. <u>Insurance</u>. DCFCM and LTSD shall maintain general and professional liability insurance coverage. Each party hereto agrees that it will indemnify and hold the other harmless from and against any and all claims, liabilities, damages, costs or expenses (including reasonable attorneys' fees) arising from or resulting in any manner from the acts or omissions of the indemnifying party, its officers, employees or agents, in connection with this Agreement.

- 6. <u>Non-discrimination</u>. DCFCM operates in accordance with all applicable civil rights laws and regulations and does not discriminate in admissions, the provisions of services, or referrals of clients on the basis of race, color, religious creed, disability, marital status, ancestry, national origin, sexual orientation, age, sex or any other class protected by law.
- 7. <u>Confidentiality</u>. DCFCM shall comply with all applicable laws and regulations regarding the confidentiality and privacy of health and mental health information.
- 8. <u>Independent contractors.</u> It is expressly acknowledged by the parties that DCFCM and LTSD are independent contractors and nothing in this Agreement is intended, and nothing shall be construed to create an employer/employee relationship, a joint venture relationship, a partnership, or other similar relationship.
- 9. <u>Conflict of laws.</u> This Agreement shall be construed in accordance with the laws of the Commonwealth of Pennsylvania.
- 10. <u>Integrated Agreement.</u> This Agreement constitutes the entire understanding and agreement between the parties concerning the subject matter hereof and supersedes all prior written or oral agreements or understandings between the parties concerning the subject matter hereof.
- 11. <u>Amendments.</u> No amendment to any provision of this Agreement shall be effective unless in writing and signed by each party.

IN WITNESS WHEREOF, the parties hereto, intending to be legally bound to the terms of this Agreement, have caused this Agreement to be executed as of the date first written above.
